



## RULES AND REGULATIONS FOR BWL MEMBERSHIP

### 1. Membership

- 1.1 BM, SBM, BBM, SD, GD and PD are all registered Independent Members of Best World Lifestyle (HK) Company Limited (hereinafter referred as BWL)
- 1.2 Valid Membership is required for participation in BWL's Enterprise Network and R4+ Programmes.
- 1.3 There exist no agreements, promises or understandings between you and BWL except as specifically set forth in these Rules and Regulations.
- 1.4 You have no right to bind BWL over any obligations or contract in any way or for any purpose.

### 2. Membership Status

- 2.1 Your Membership shall be deemed active if you had made any purchase of products with PV or RU in the last 12 months.
- 2.2 If your Membership is expired, your Membership shall be deemed to have lapsed completely. This shall result in the deactivation of the Member's status from the line of sponsorship and nullification of your entitlements in the ENP.
- 2.3 If you wish to participate in the ENP after your Membership has lapsed, you are required to re-register as a VIP or BA. However, reserves the right not to accept the application for re-registration and BWL's decision is final.
- 2.4 You are not allowed to transfer or change your upline after your Membership has been activated.

### 3. Inheritance And Transfer

- 3.1 Membership is non-transferable by commercial or non commercial transaction.
- 3.2 Your rights and interests to BWL's Enterprise Network and R4+ Programme can be willed. The beneficiary can only take possession of the inheritance as a result of old age emigration, disability or death of the Member.
- 3.3 The beneficiary must be your immediate family member and be aged 18 and above. He/she shall meet the respective eligibility and continue to perform your duties and responsibilities in order to participate in BWL's Enterprise Network and R4+ Programmes.
- 3.4 If a beneficiary has not been appointed after 6 months of the decease of the Member, the Membership will be deemed non transferable and unfit for inheritance.

### 4. Termination

- 4.1 You may self-terminate your Membership at any time by sending a registered letter to BWL. The resignation letter must include full name, member code, identity certificate/document number and signature. This shall result in the deactivation of your status from the line of sponsorship and nullification of your entitlements henceforth according to ENP. You shall only be re-registered after 180 days from the date of termination. BWL reserves the right not to accept application for re-registration and its decision is final.
- 4.2 If you have been discovered to violate business Rules or Regulations, member agreement or bonus plan ie the ENP or related corporate business laws, BWL is authorized to take decisive action, to suspend or to terminate Membership. BWL reserves the rights to take legal actions to recover the loss incurred by the abovementioned violation, including the cost of arbitration, court fee and lawyer expenses.

### 5. Responsibilities of a Member

- 5.1 You shall make your best efforts to obtain information concerning product, promotion and procedures released by BWL.
- 5.2 You shall manage your own group of Members at your own expenses, which may include, but are not limited to telephone contact, marketing materials, training, meetings, advertisement, entertainment and rental incurred from any events organized by you.
- 5.3 You shall provide training and education about BWL's Product, Enterprise Network and R4+ Programmes to your downlines.
- 5.4 You shall conduct regular follow-up, supervision and review with your downlines.
- 5.5 You shall adhere to selling products to non-member at Selling Price (SP) and Member at Distributors Price (DP).
- 5.6 You agree to abide by the Rules and Regulations and to make your best efforts to recommend BWL's Product, Enterprise Network and R4+ Programmes.

### 6. Prohibited Activities

- 6.1 You shall not make any false or misleading representation about BWL, its entity, its business and its products.
- 6.2 You shall not omit any material particular to BWL's products.
- 6.3 You shall not use fraud, coercion, harassment or resort to any unlawful means in promoting BWL's products.
- 6.4 You shall not display products in shops of any nature which are not authorized stockist (Lifestyle Centre).
- 6.5 You shall not send out unsolicited emails and Short Message Service (SMS) messages to promote BWL's business and/or product.
- 6.6 You shall not make use of any of BWL's intellectual properties without its formal written consent.

### 7. Bonuses

- 7.1 Commissions, rewards, incentives, sharing and benefits (hereinafter referred to as Bonuses) are all expressions used by BWL to describe the privileges which a qualified Member will receive.
- 7.2 Point Value (PV) shall be calculated in Chinese Yuan Renminbi (RMB) whereby R4 Unit (RU) shall be calculated in the participating countries' local currencies. BWL shall decide on the appropriate exchange rates for bonus calculations.
- 7.3 The total Point Value (PV) and R4 Unit (RU) accumulated by Members in the various countries shall be consolidated and calculated in BWL's Singapore Headquarters.
- 7.4 All Bonuses which you have accumulated from both local and foreign markets will be distributed by BWLHK in Hong Kong Dollar.
- 7.5 Bonuses shall be issued on 15th day of the month made in the form of electronic payment. In the event that the 15th day falls on a public holiday, bonus payment shall be issued on the next working day.
- 7.6 You shall submit your bank account detail in order to receive your Bonuses.
- 7.7 BWL reserves the right to recall the excess Bonuses given out to you.
- 7.8 Accrued Bonuses not being claimed by you within a period of one (1) year from the date of issue shall constitute a waiver of your rights to the Bonuses thereof, and this shall result in the forfeiture of any Bonuses, claims, or whatsoever from BWL.
- 7.9 In countries where the law stipulates a valid citizenship or work permit in order to receive Bonuses, BWL will require you to submit copies of identity document, tax reference number or work permit to legally qualify for the bonus entitlement. BWL shall not be liable for any bonus payout if the requirements are not being met; BWL is also not obligated to participate in the involvement of handling citizenship documents, tax reference number, work permit application or payment to relevant authorities. You have to handle the registration process independently and bear all costs.

### 8. Taxes

- 8.1 You may obtain yearly income statement from BWL upon request.
- 8.2 You have the responsibility and duty to pay your taxes, in order to comply with the tax regulations of the respective countries.
- 8.3 For your Bonuses contributed from foreign markets, BWL reserves the rights to deduct any withholding tax in accordance to the tax authorities of the respective countries, without prior notice given to you.
- 8.4 BWL reserves the right to request for passport copy or any other identification documents for withholding tax purposes in the event of foreign commissions. You shall accept full responsibilities for the non-payment or delayed payment of foreign bonuses should you fail to produce the required documents on time.
- 8.5 You must obtain a local tax number and relevant permits for the process of their bonus entitlement in countries where the law stipulates this as a regulated practice for any business activities if you intend to conduct international sponsoring activities.
- 8.6 To comply with the laws of the relevant tax authorities, BWL reserves the right to request for a passport copy local tax reference numbers, or any other identification certificates/documents for withholding tax purpose in the event of foreign Bonuses. You shall accept full responsibility for the non payment or delayed payment for foreign Bonuses, should you fail to produce the required documents on the time.

### 9. Others

- 9.1 You are expected to update any changes to your personal information, or fill in the amendment form to BWL to prevent discrepancies that may occur during communication and delivery of information.
- 9.2 BWL reserves the rights to change the product price, R4 Unit (RU) and Point Value (PV) according to market conditions.
- 9.3 You understand that these Rules and Regulations on your Membership may be amended and updated by BWL at its sole discretion, without prior notice.
- 9.4 You shall refer to BWL Member Handbook for any Rules and Regulations not stipulated on this form.
- 9.5 BWL reserves the rights to amend and/or change the Rules and Regulations as and when BWL sees fit.
